Science Integration - Ocean Science Trust continued to fulfill its mission of ensuring that ocean and coastal management decisions are supported by the best available science, including identifying science needs for decision-makers, managing relevant science studies, and linking end-users with scientific and technical information. In its role as a boundary organization functioning the space between science and decision-making, OST continued to improve collaboration among scientists, policymakers, and resource managers and develop processes to connect science and scientists with state agencies and coordinating bodies, such as the California Ocean Protection Council (OPC). OST continued to lead the development and implementation of MPA monitoring to evaluate the effectiveness of the new MPAs being established under the MLPA. California's waters have been divided into five regions, which are currently in various stages of the MPA implementation process. For each of these regions, OST is developing and implementing MPA monitoring through a series of 6 steps: 1) planning MPA monitoring 2) implementing MPA monitoring 3) managing information 4) analyzing data 5) reporting results, and 6) fostering innovation. Between October 2011 and September 2012, OST implemented baseline MPA Monitoring in South and North Central Coast regions, has begun analyzing data and reporting results for the Central Coast region, initiated monitoring planning in the North Coast region, and launched the community platform, OceanSpaces. OST also continued to coordinate the OPC Science Advisory Team (OPC-SAT), Continued Sch. O
